ABSTRACT

Public Works Puducherry – Monthly Sewerage tariff and One Time Deposit for Sewerage Connections to underground sewerage system notified while implementing Reforms as per guidelines of JNNURM Scheme – Withdrawal of one time deposit charges for a period of first six months for new Domestic/Residential sewerage connections alone – Orders – Issued.

ORDER:

The following notification shall be published in the Official Gazette of Government of Puducherry.

NOTIFICATION

The Government of Puducherry, while implementing reforms as per guidelines of Jawaharlal Nehru National Urban Renewal Mission (JNNURM) Scheme, has fixed rates for the monthly sewerage tariff and one time deposit charges for each connection to various categories of sewerage connections in Puducherry in respect of two types of buildings viz., (1) Domestic/Residential Buildings and (2) Commercial Buildings, vide G.O. 1st read.

2. Now, the Government of Puducherry hereby accords approval for the withdrawal of one time deposit charges for new underground sewerage connection in respect of only the Domestic /Residential Buildings, for a period of first six months from the date of publication of this notification in the Official Gazette, subject to implementation of the following actionable points:

- (i) Most of the households have individual toilets connected to septic tank and choke pit/disbursal trench. The households are reluctant to connect the toilets directly to underground system, as it involves financial investment, apart from demolishing the existing septic tank and choke pit. The request for connecting choke pit into underground system can be considered.
- (ii) In case of direct connection of household toilets to underground system, the existing septic tanks may be used for rain water harvesting after due remediation.
- (iii) All the private owned septic tank cleaning vehicles should be registered with concerned local body authorities. The operators should be instructed to discharge the septage fillings only into the PWD run STPs at free of cost. Such vehicles should be fitted with GPS system for monitoring movements by local body authorities. Public Works Department also should keep record of disposal of septages at each STP.
- (iv) A Joint Task Force team can be constituted with officers of local bodies and Public Works Department to carry out survey and to identify the households, industries and other establishments which are yet to be connected to the underground sewerage system. The team will persuade the occupants to effect connection at the earliest.
- (v) The system of granting road cutting permission by local bodies and PWD should be simplified. After road cutting, PWD should make the streets fit for traffic by filling with quarry dust as a temporary measure. The local bodies will make permanent restoration in due course.

- (vi) Households, industries, commercial establishments etc. which discharge toilet septage directly into public drains should be given a short notice to connect with underground drainage system. If they fail to do so, the Commissioners of local bodies should take action to plug the illegal drainage/sullage let out points by invoking the powers under municipal laws.
 - (vii) The sullage water from households, industries, commercial establishments etc. should invariably be connected to underground drainage network system so as to keep the drain/canal free from sullage and to make the city clean.
 - (viii) The officers of local bodies and PWD should regularly meet and sort out the issues. The Superintending Engineer-II, PWD will be overall incharge to achieve 100% connection of households etc. to underground system.
3. There shall be no change in the one time deposit charges of sewerage connections in respect of Commercial Buildings and the same shall be collected as fixed in the G.O. 1st read.
4. There shall also be no change in the rates fixed towards monthly sewerage tariff vide the G.O. 1st read and the same shall be collected from all the existing and new sewerage connections in respect of both the Domestic/Residential Buildings and the Commercial Buildings.
5. Further, the Local Bodies (Municipalities/Commune Panchayats) shall be involved in persuading the consumers to get sewerage service connections and enforce the Puducherry Municipalities Act, 1973 for ensuring that the consumers connect to the sewerage Network for keeping the town/city/water bodies clean and hygienic.
